Alternergy Holdings Corporation ("ALTER") announced that it has sealed a PhP2.4 billion co-investment for 40% stake in its Tanay and Alabat wind projects from ABC Energy Inc. ("ABC Energy"), the energy holding subsidiary of listed A Brown Company Inc.. ABC Energy will acquire a 40% equity stake in each of two (2) ALTER project companies, Alternergy Tanay Wind Corporation ("ATWC") and Alabat Wind Power Corporation ("AWPC"). ALTER's wind holding company, Alternergy Wind Holdings Corporation ("AWHC"), will retain majority 60% ownership in ATWC and AWPC.

<u>Proceeds from the co-investment is in line with ALTER's strategy to recycle capital to fund its project pipeline in wind, solar, run of river and battery storage.</u>

AlphaPrimus Advisors and Astris Finance acted as Joint Financial Advisors to ALTER while Mabuhay Capital acted as Financial Advisor to ABC Energy. Romulo Mabanta Buenaventura Sayoc & de los Angeles acted as legal counsel to ALTER while Picazo Buyco Tan Fider Santos & Dee acted as legal counsel to ABC Energy. The transaction is subject to regulatory review and/or approval by the relevant governmental agencies, such as the Philippine Competition Commission ("PCC").
