Please be informed that Alternergy Wind Holdings Corporation (Formerly: Pililla AVPC Corporation) (hereinafter referred to as “AWHC”), a fully-owned subsidiary of Alternergy Holdings Corporation (hereinafter referred to as the “Corporation”), received today, 12 April 2024, the Certificate of Filing of Amended Articles of Incorporation (“AOI”) and Certificate of Filing of Amended By-Laws issued by the Securities and Exchange Commission for the approval of the amendment of the following articles of the AOI and By-Laws of AWHC:

I. Articles of Incorporation

1. Article First – To reflect the change in corporate name to “Alternergy Wind Holdings Corporation”; and
2. Article Third – To reflect the change in principal office address to “Level 3B, 111 Paseo de Roxas Bldg., Paseo de Roxas Avenue corner Legazpi Street, Legaspi Village, Barangay San Lorenzo, Makati City 1229” to make it consistent with the GIS of AWHC;

II. By-Laws

1. Name – To reflect the change in corporate name to “Alternergy Wind Holdings Corporation”;
2. Article II, Section 1 - To reflect the change in the date of the Annual Stockholders’ Meeting to every last Tuesday of November of each year; and
3. Article VI, Section 2 – To reflect the change in fiscal year to the last day of June of each year.

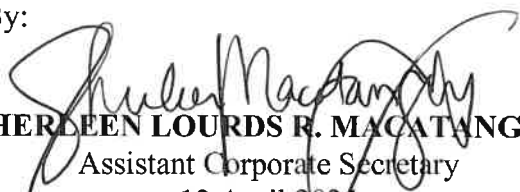
